RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of my participation in the Sailing Adventure Club, Inc. ("SAC") referenced above, I hereby agree, acknowledge, and appreciate that SAC is a not-for-profit organization for adults providing a variety of activities for its members and guests, and that I recognize that my activity, sail, or travel arrangement with SAC, its Officers or Board of Directors, or any Skipper, First Mate or Agent thereof, may be hazardous by reason of the nature of the activity, travel arrangement, or trip.

- I HEREBY RELEASE AND HOLD HARMLESS WITH RESPECT TO ANY AND ALL CLAIMS, INJURY, DISABILITY, OR DEATH, or loss or damage to person or property, WHETHER CAUSED BY NEGLIGENCE OR OTHERWISE by SAC, its officers and directors, members, or SAC trip participants (herein referred to as releasees).
- I agree to fully release the releasees, their officers, directors, representatives, and volunteers from all liability and responsibility whatsoever, and from any claims or causes of action that I, my estate, heirs, executors, successors, survivors, or assigns may have for personal injury, property damage, or wrongful death arising from the above activities, whether caused by active or passive negligence by the releasees or otherwise. By executing this document, I agree to hold the releasees harmless and indemnify them in conjunction with any claim, injury, disability, death, or loss or damage to person or property that may occur as a result of my engaging in any SAC-related activities.
- I additionally agree to be solely responsible for any intentional acts of myself that may result in injury or damage to equipment, boat, or other item owned or chartered by SAC, the skipper, or other persons.
- I accept the continuing responsibility to acquaint myself with the hazards and risks inherent in any SAC activity or trip, and I agree to not participate in any activity unless I fully understand all risks inherent in such participation. By signing below, I acknowledge personal liability for the same.

I voluntarily assume, and continue to assume, the risk of accident and/or injury to my person or possessions that may occur on this trip and activity.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT; I FULLY UNDERSTAND ITS TERMS; I UNDERSTAND THAT I HAVE GIVEN UP LEGAL RIGHTS BY SIGNING IT, AND I SIGN FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
